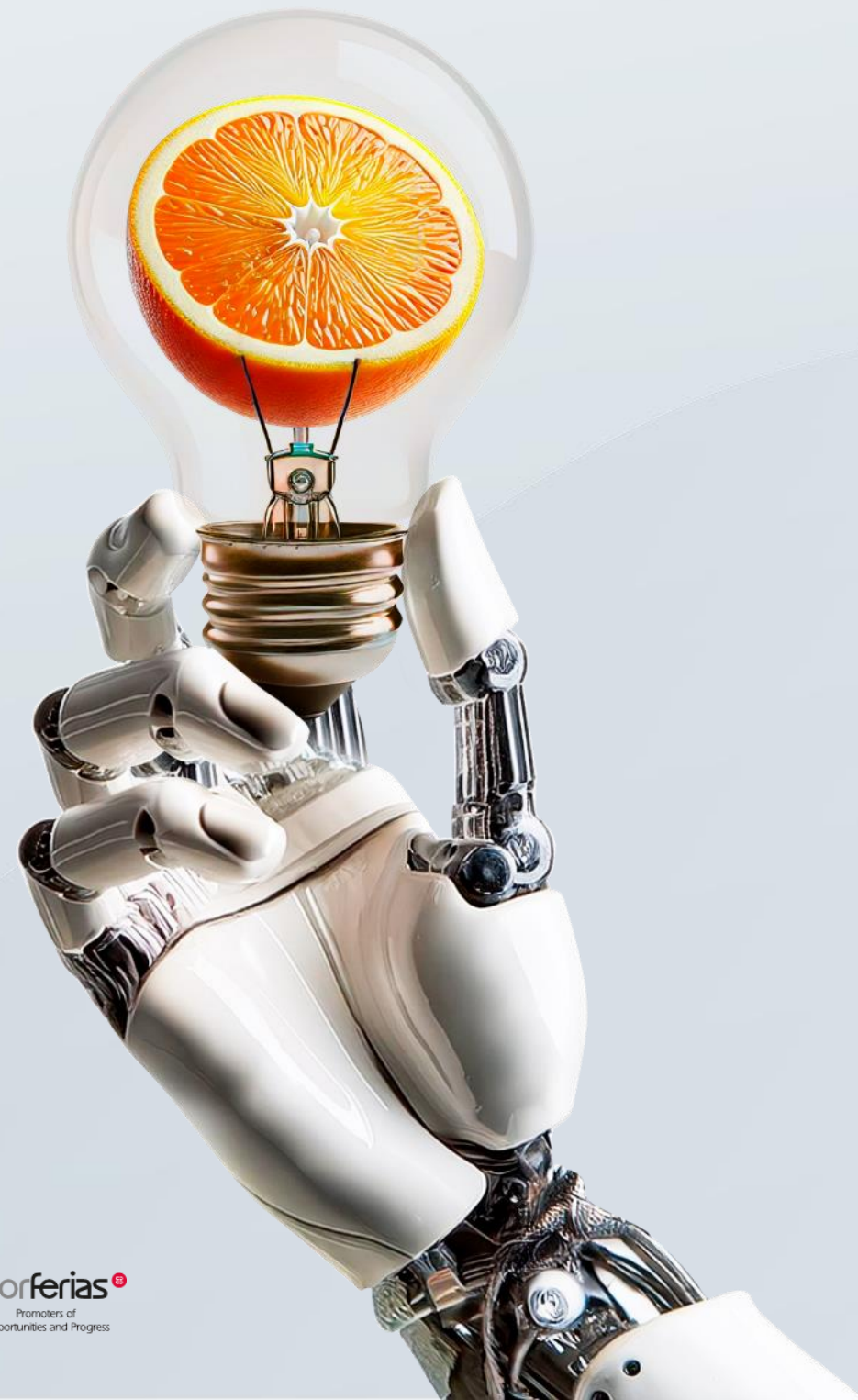
POLICIES FOR THE REALIZATION OF SOCIAL EVENTS

Organizers:



- ✓ For the optimal development of your company's various activities at the Createx Fair, Corferias establishes policies for social events. These policies seek to contribute to the participation and achievement of our exhibitors' objectives, creating a pleasant, social, and commercial environment.
- ✓ Events of a social, artistic, or cultural nature that involve the supply and tasting of liquor and food must be reported to Corferias for approval (Project Manager) prior to the start of the Fair. The Project Manager will authorize or deny the event after analysing the type of event, its objective, the profile and number of attendees, and the location and time of the event. Exhibitors must sign a commitment with Corferias to comply with the logistical and safety requirements required for this purpose.

- ✓ The activity must take place during trade show hours, between 5:00 PM and 8:00 PM.
- ✓ The venue for the activity must be limited to the internal area of the respective stand (under no circumstances may mobility areas within pavilions or other stands be invaded).
- ✓ No type of technological sound amplification equipment may be used, and any musical cultural activities must comply with the standards established in Resolution 0627 of 2006, the National Noise Emission Standard.
- ✓ Responsibly and reasonably manage the supply of liquor to event guests (an international standard recommends that for a cocktail-type event, the average amount per person is 3 drinks and 5 snacks).
- ✓ Once the number of invited guests has been established, a simple rule will be used to establish the number of bottles authorized for admission, based on the principle that a 750 ml bottle is 100% suitable. 20 shots of a 750 ml bottle of whiskey may be served, and 8 shots of a 750 ml bottle of wine may be served.
- ✓ The sale, supply, or consumption of alcoholic beverages to minors is prohibited.

If the Exhibitor does not comply with the provisions, the following sanctions will be imposed:

- ✓ **First warning:** Corferias will deliver to the Exhibitor a letter evidencing the warning and in which the non-compliance is referenced and in which it is warned that if the fault is repeated or a new one is incurred, the organizers of the Fair will be forced to impose the corresponding additional sanctions.
- ✓ **Second warning:** After the first warning is presented to the Exhibitor and he/she repeats the non-compliance with any of the provisions, Corferias will cut off the energy service at the Exhibitor's stand for the rest of the day and the Exhibitor will have to pay a fine corresponding to 2 SMMLV* .
- ✓ **Third warning:** Once the two warnings have been presented and if the Exhibitor fails to comply again, the sanction will be applied to the cutting off the power service at their stand for the rest of the day and they will have to pay a fine corresponding to 4 SMMLV. This fine must be paid before May 9, 2024, otherwise the exhibitor will not be able to access the peace and safe, which allows them to leave the fairgrounds.
